1. APPLICANT MUST BE A CURRENT GRADUATING SENIOR WHO IS ATTENDING A CUMING COUNTY HIGH SCHOOL – BANCROFT-ROSALIE, CENTRAL CATHOLIC, WEST POINT-BEEMER, OR WISNER-PILGER THAT IS APPROVED AND ACCREDITED BY THE STATE DEPARTMENT OF EDUCATION.
2. APPLICANT MUST BE SEEKING CONTINUED EDUCATION AT A NEBRASKA UNIVERSITY, COLLEGE, TECHNICAL OR TRADE SCHOOL OF APPLICANT’S CHOICE
3. APPLICANT MUST HAVE A MINIMUM OF A “C” AVERAGE ON THE ALPHA SCALE OR 2.0 NUMERICALLY.
4. APPLICANT MUST PROVIDE TWO (2) CONFIDENTIAL REFERENCES WITH ONLY ONE BEING FROM A TEACHER. ALL REFERENCES SHOULD BE FROM A NON-RELATIVE.
5. THERE IS NO LIMITATION ON PERSONS WHO ARE ELIGIBLE RECIPIENTS OF SCHOLARSHIPS. SCHOLARSHIPS WILL BE GIVEN WITHOUT REGARD TO RACE, CREED, RELIGION, NATIONAL ORIGIN OR SEX.
6. SCHOLARSHIP MONIES MUST BE USED WITHIN ONE ACADEMIC YEAR (JUNE 1, 2017 THRU JUNE 1, 2018)
7. SCHOLARSHIP FUNDS WILL BE SENT TO THE SELECTED RECIPIENT WHEN THE WEST POINT FOUNDATION SCHOLARSHIP COMMITTEE HAS BEEN PROVIDED WITH PROOF THAT THE STUDENT HAS ENROLLED IN SCHOOL. PROOF MAY BE A PHOTOCOPY OF THE STUDENT’S COLLEGE, TECHNICAL OR TRADE SCHOOL I.D. CARD.
8. THE SCHOLARSHIP COMMITTEE WHO ARE MEMBERS OF THE WEST POINT COMMUNITY FOUNDATION WILL SELECT SCHOLARSHIP WINNERS.
9. APPLICANT MUST SIGN A LETTER OF EXPECTATION AS ACCEPTANCE.
